

  It is important to be respectful of the judge and the other party involved in the case.

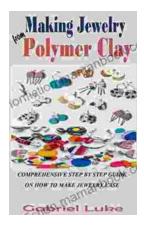

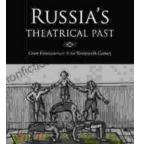
